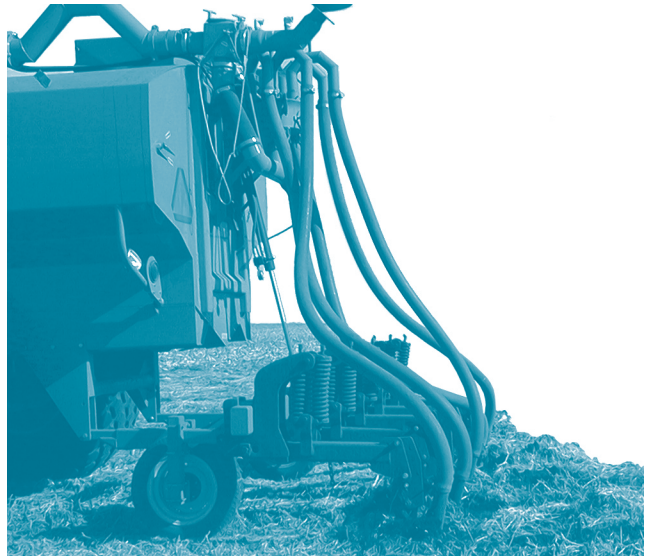


2006 Confinement Site Manure Applicator Workshops



This brochure contains a state-wide list of workshops for the Confinement Site Manure Applicator Program. State law requires confinement site manure applicators to be certified to handle, haul, transport or apply manure liquid or dry manure coming from a confinement facility with more than 500 animal units. These workshops will qualify for initial certification, continuing education and recertification requirements. Workshops will provide the mandatory 2 hours of annual training required by state law. Commercial manure applicators are required to attend 3 hours of annual training and should plan to attend the satellite downlink on January 6, 2006 to meet their annual requirements.

Initial Certification

Initial certification can be completed by attending one of the 2 hour workshops listed in this brochure, scheduling an appointment to watch

the 2 hour video at your county extension office or by taking and passing the certification exam at your regional Iowa Department of Natural Resources (IDNR) field office.

Continuing Education

Applicators must attend 2 hours of training each year of their 3-year certificate or take and pass the exam once every three years to maintain certification. Once you attend your initial certification, you are certified for 3 years, however, if you do not maintain your certification by attending 2 hours of annual training via a workshop or video, you will be required to take the “make-up” exam prior to being eligible for recertification at the end of the 3-year license.

Recertification

If you miss one year of training during your 3-year license, Iowa law requires you to pass a written exam to be eligible to recertify. Applicators who missed a 2 hour workshop during their 3-year license will be notified with a letter from the IDNR stating the need to take the exam to

be eligible to recertify. Upon passing the exam, applicators may either take a second exam (on a different day) or attend a 2 hour workshop to initiate the certification cycle for the next 3 year period.

If you completed all required training in the 3 year period, you may initiate you next 3-year certification by passing one exam or by continuing to attend the 2 hour workshops or watching the 2 hour video annually.

Uniform Deadline and Fees

All confinement site manure applicator certificates will expire on December 31 of the third year of their certification. Confinement site applicators will have until March 1 following the year their certificate expires to attend their 2 hour annual training. Applications for recertification received at IDNR postmarked after March 1 will be considered late, a late fee will be charged. An applicator will not be considered certified until all fees are paid, including the late fee, and all appropriate forms are submitted to IDNR.

Exams

Certification exams are administered by IDNR. You must make an appointment at your regional IDNR field office to take the exam. The exams have 50 multiple-choice or true-false questions. Fees and Forms

There is no fee to attend a workshop, watch a video or take the exam. Fees for the 2006 certification program will include the \$100 certification fee for new applicators and applicators renewing certificates (fee paid once every 3 years), a \$25 annual education fee as mandated by the law in 2003

and any applicable late fees. Fees are made payable to IDNR. In addition to the required training or testing, applicators must submit the appropriate forms and fees to the IDNR to be certified. Please bring a copy of your applicator license to the exam, workshop or video showing.
